Terms and Conditions

The Off Grid Events Inc. and "Off Grid Lifestyle Expo" refers to the Organisation. "Exhibitor" refers to the Company and or person named on the Booking Form including its owners, employees, and representatives.

These terms and conditions serve as a legal binding agreement between the Exhibitor and Off Grid Events Inc. and may not be varied except by written agreement between both parties, Businesses will not be able to exhibit unless they have read, understood, and signed these terms and conditions.

1. Conditions:

- a. Off Grid Events Inc is committed to reducing the waste that we as humans produce, our aim is to be Waste Neutral at the Expo. We ask that all Exhibitors also take this seriously. As part of this agreement, the Exhibitor will be responsible and commit to a waste neutral site. Please aim for no plastic waste and as the Exhibitor try to find ways that you can still display and contain your products to this end. We do understand that not all products are able to not be displayed in this way but let us all endeavour to move towards this aim. Please discuss this with Off Grid Events Inc. organisers if you are unsure.
- b. The Exhibitor has agreed to attend the Off Grid Lifestyle Expo 2022 and to display relevant information about their products and services in their designated/allocated area.
- c. To confirm your participation as an Exhibitor, the Booking Form must be signed. This then constitutes a signed contract and agreement with all the terms and conditions of the Organisers. Full payment of the stall site is completed and a copy of your company's current Public Liability Insurance and if applicable Product Liability Insurance and Food Preparation and Food Service Certificates are received.
- d. Your Company/Business/Product/Personal Name may be included in any promotional material or initiatives used by Off Grid Events Inc. to promote the Expo once your reservation has been confirmed.
- e. You and your Company/Business/Person agrees for Off Grid Lifestyle Expo to use photographs and video taken of you and/or your business during the promotional period before, during and after the Expo dates for all publicity purposes including promotional flyers, news articles, websites, newsletters, social media pages or profiles, and magazines. Including my image and any image personally photographed.
- f. Failure to abide by any and all conditions could incur a \$500 penalty.

2. Set up and Dismantle Times:

- a. No displays on stall sites are to be set up, dismantled, or removed during the Expo or prior to the conclusion of the Expo due to insurance and OHS requirements. There are no exceptions unless organised in writing prior to the Expo. Failure to abide by this rule will incur a bond for any future involvement in Off Grid Events Inc. events of \$1,000. All Exhibitors must be set up by 7.30 am on Saturday 3rd of September 2021. Dismantling of your stall site is not allowed until 4:00 pm on Sunday 4th of September 2022. Set up will be available on Friday 2nd from 12 noon onwards or by prior arrangement. Some pull down on Monday by arrangement will also be an option.
- b. Exhibitors' access and vehicle access times will be specified by Off Grid Events Inc. and must be complied with by all Exhibitors. All vehicle movement during specified event times must be accompanied by an Off Grid Events Inc. staff member.

3. Exhibition Space:

- a. The Exhibitor will be provided with an allocated space. Products, display material including banners, brochures and other promotional material must remain within the confines of their allocated area. They must not obstruct, interfere, or impede any other exhibit and must keep aisles and walkways clear at all times. The Exhibitor is responsible for providing ALL equipment needed for the stall including Marquee and table/s.
- b. The Exhibitor must keep their allocated area in a clean and tidy fashion at all times.
- c. The Exhibitor has agreed not to display or give benefit to any other business outside the Exhibitors own. Under no circumstance is an Exhibitor to share or sublet a stand or display other business's promotional material without prior permission from the Organisers.
- d. Exhibitors must remove ALL rubbish and leave their site in a neat and tidy condition. This includes any leftover promotional material to be placed in the correct bins provided throughout and at the conclusion of the Expo. Any additional cleaning costs incurred by Off Grid Events Inc. will be payable by the Exhibitor if they have not complied with this requirement.

4. Exhibitor Responsibilities:

- a. Exhibitors must always have a suitably responsible and informed representative for their stand. If assistance is required for speaker or workshop times, the Committee is happy to help.
- b. Under no circumstances shall the Off Grid Lifestyle Expo organisers, sponsors or supporters be held liable for damage to property, injury to any person, financial loss or legal damages directly or indirectly arising out of the Expo. The Exhibitor shall indemnify and keep indemnified the Expo against all costs, damages, claims or proceedings.
- c. All Exhibitors shall arrange their own appropriate security if required. There will be wandering security on Friday and Saturday evenings supplied by the organisers. The Off Grid Events Inc. shall not be held responsible or liable whatsoever for damages to an exhibit by loss, damage, fire water, storms, strikes, riots or any other cause whatsoever.
